RESOLUTION 01.05.2021:2: Attorney Brandon Voelker read a resolution appointing John Lucas as Assistant Fire Chief for a two-year term ending December 31, 2022.

MOTION: Luke Price made a motion to approve **Resolution 01.05.2021:2** approving Assistant Fire Chief appointment; seconded by Amy Hurst. Motion carried by vote of 4-2-0. No votes by Sebastian Ernst and Craig Owen.

RESOLUTON 01.05.2021:3 Attorney Brandon Voelker read a resolution to surplus certain equipment and vehicles of the Falmouth Fire Department. Interlocal Agreement with Pendleton County for fire protection.

CAUCUS MEETING



Mayor Stinson then began departmental reports:

Shannon Clem: Reviewed with Council the report submitted on calls answered for December. He was thanked for the additional report on nuisance calls and appreciated being kept apprised of the properties not in compliance.

Gary Lea: Reported there was nothing major going on; routine maintenance issues, taking down the Christmas lights.

David Klaber: provided the fire department report covering fire runs for the month of December and noting it was a busy month.

Andy Richie: reported he was awaiting parts to finish pump repairs; report of alarms at Cardinal Ridge and waiting electrical issue for another pump.

Ramona Williams: Deferred to Brandon on an email response regarding the ability to apply penalties again on delinquent utility bills. The Governor's order was through December 31, and the question was to apply with the bills due January 10th which was for December usage or wait until February bills. To be safe, it was decided based on verbiage of order, the usage for December would not be eligible for penalty, rather the January usage. Penalties will resume with the bills received in February for January usage.

Other items discussed:

- Mayor Stinson encouraged new Council members to make time and meet with Bill
 Mitchell on the current projects. He explained briefly the Klee property, the retention
 basin project at the sewer plant, and painting of the water tank.
- An update from Michael Lanin with the Headstart building was moving forward, but no new activity to report at this time.
- Sebastian Ernst requested to add the fire department ordinance to the next meeting agenda for review.
